Dear Leader McConnell and Leader Schumer:

On behalf of the American Council on Education (ACE) and the associations listed below, we write in support of bipartisan legislation being considered in the Senate that would grant legal status to 1.8 million Dreamers.

The amendments offered by Senators McCain and Coons and by another group that includes Senators Rounds, King, Collins, Manchin, Graham, and Kaine have the best chance of passage along bipartisan lines. Both would allow Dreamers to pursue their lives with certainty and stability, providing them with a long-term permanent solution. These amendments represent reasonable compromises by both sides of the aisle.

As leaders in the higher education community, we have seen Dreamers up close on many of our campuses. These amendments underscore the broad, bipartisan commitment, as well as the overwhelming support from the American public, to creating a path to citizenship for these outstanding Dreamers who were brought to this country illegally through no decision of their own.

For over a decade, we have advocated for a long-term legislative fix for Dreamers. And following the rescission of DACA last year, more than 800 college and university presidents urged lawmakers to take action to protect DACA registrants, as did nearly 80 higher education associations.

We urge you not to let this opportunity pass. We respectfully request you support legislation that protects these outstanding individuals, who are Americans in every way but immigration status, and are making countless positive contributions to our nation.
