AASCU Membership Requirements

Institutional Membership . . .

shall be available to any regionally accredited institution of higher education and any in process of securing accreditation, which (1) offers programs leading to the degree of bachelor, master, or doctor, (2) is wholly or partially state-supported and state-controlled; and (3) at least 25 percent of degrees conferred by such institution are at the baccalaureate level and are in areas of study defined in AASCU policies and procedures.

System Office Membership . . .

shall be available to system offices of multi-campus governing boards of eligible state-supported and state-controlled institutions of higher education which are wholly or partially state-supported and state-controlled.

Associate Membership . . .

shall be available to coordinating committees, boards and commissions of higher education which report to state executive or legislative bodies; state commissions of eligible institutions; institutions of higher education whose principal source of operating funds is the federal government; and former two-year institutions that have been designated as four-year institutions by the responsible authorities within their state, but have not yet met the requirements for AASCU membership.

International Associate Membership . . .

shall be available to (institutions outside the United States and its territories that are: (1) recognized by the appropriate governmental entities as eligible to award degrees at the baccalaureate level or higher; and (2) wholly or partially government-supported and publicly governed, and (3) associations comprised exclusively of such institutions.
